## success **STORY**

### As told by Aks Crisis line volunteer - Priya Parkhi

Puja (Name Changed) called me on 4th of July,2016. Initially unable to speak and sobbing, she eventually spoke in a very gentle voice, "My husband has beaten me up and I'm new to the city, I need help". I met an immensely distraught Pooja on the same day, along with her 2 and a half-year-old son. Having assured her that we would help, she told me her story.

This was her second marriage and it was in a terrible state. Her husband was not only eyeing her father's money but also abusing her physically and emotionally. Nishant would lose his temper, often over trivial things, and would assault her with whatever he found at arm's length, sometimes a hanger, a belt and on instances threw an alarm clock and jewelry box at her. He had shoved his fist in her mouth and scratched her throat. A petite woman, she would be pushed around often. He refused to give her money to run the house and, embarrassingly, she'd had to ask her parents for financial help. Her in-laws who lived in a different city had turned a blind eye towards the whole situation. Her first marriage ended when her husband was diagnosed with a personality disorder that made it impossible to live with him. Her parents supported her and helped her cope with that difficult phase. This time they refused to even acknowledge that she was being abused. Her father, in an attempt to understand and see his daughter happy, would buy Nishant expensive gifts and at times apologize on her behalf. which in turn would feed his narcissistic ego. The social stigma of a second failed marriage was something her parents were not ready to face. She showed me the bruise marks on her back and shoulders. Her response to the abuse was to try and normalize the situation by playing nice, while her husband would become cold and quiet. Their son had started realizing what was happening and after their fights, would hug her and wipe her tears.

The next day, a medical report confirmed that the bruise marks were caused by abuse. Unwilling to go to the police, Puja was consulted by our lawyer who made her aware of legal rights. We continued to meet at intervals, across eight months. Through our meetings, I educated her about the power and control wheel, created safety plans, successfully encouraged her to acquire a job and build a support system at work and in her society. We established safety codes which could be messaged during dire situations.

With time, when an abusive episode occurred, friends from work would pick her and her son up and take them home. Her husband started feeling shameful. She started retaliating and her neighbors soon found out too. Observing her support system getting stronger, her husband realized he could be punished and stopped hitting her but ramped up the emotional abuse to break her spirit. He hired a man Friday who acted as his informant. He forced her to pick up after the domestic help had eaten. He would drink with him at home and make her serve both of them, insulting her time to time by telling her that he would rather her leave than the man Friday.

She would call and cry hysterically, but over time and with a calm resolve she began taking necessary steps because she could clearly see Nishant's pattern of abuse. She began with saying "no", slowly she stopped apologizing when she was not at fault. Then she started giving him ultimatums, making him aware that his career would be ruined if she reached out to his company and he would also lose his son. Eventually, he started backing off. After more than a year of counseling, emotional breakdowns, going back and forth over a decision to take legal action or not, Puja finally found a middle ground and she stood firm.

This story does not have a fairytale ending but it does show the realities of abuse and the strength one has to take a stance against it. Puja did not back off, she faced the abuse resiliently and created her own space where she now commands respect. I did hear from her at scheduled times for a while but now the voice on the other side seemed much stronger and a self-confident one.

# letter FROM THE EXECUTIVE DIRECTOR



Aks is an NGO with a heart, a heart that is kept beating with the lifeblood that comes from our dedicated and selfless volunteers.

The Aks motto is to "listen, empathize, believe & empower"

The word Aks means reflection in Pharsi. The reason I used the word reflection to represent our organization is because we are a reflection of the society we live in and we have to understand each and every caller within the context of this society.

Our volunteers act as the mirror to our clients to help them see and understand their own barriers that prevent them from breaking away from the clutches of violence and abuse.

Aks, was an idea, an idea that was planted in my head while studying in the United States and did my first few practicum and internships in Denton County Friends of the Family (DCFOF), where I later grew to be a staff counselor. The idea was to replicate this good work back home, a way of giving back to the country of my birth. It was a naive and idealistic plan and even though I came back with a lot of passion, I was doing this work only in an individual capacity for the first few years.

In 2012, the Nirbhaya case occured and as a woman, my world shattered, my faith in humanity was questioned and my ideal view of what it is to be a woman in India took a rude shock. Was this possible? Could this happen to me just because I got on the wrong bus? My idea of a just world was challenged and I saw how patriarchy and its ideals were creating a country where women couldn't be truly free.

I had worked with rape survivors for over 3 years in the US and had over 3000 hours of counseling experience with survivors of all kinds of abuse and trauma and it took something of this magnitude to shake me out of my reverie. I could actually make a difference and here I was letting all that I had learnt go unused. As I walked at a silent candlelight march with tears in my eyes for Nirbhaya, I realized how futile it was compared to what my training and exposure could do for the women and children of my country. In that very moment, Aks was born - that is the day the seed of Aks grew into a small sapling. It took a fundraiser, training of keen volunteers and the Aks crisis

lines were launched on the 15th of August, 2013. No NGO status, just a hotline for people to dial into, in times of crisis.

The crisis line had only 3 motives:

- + No one victimized by gender-based violence should feel alone
- + Someone in crisis should be able to call at the very instant which meant that the lines would have to be answered 24/7
- + Our primary role as an organization would be to empathize and empower survivors, not to raid and rescue

I wanted every woman, child or man who had been abused and victimized to know they could reach out and have someone just listen to them. No judgment. Just acknowledgment and empathy. We started with just 6 volunteers in 2013 and we received only 47 calls in the first year! Today, the Aks crisis lines are almost 5 years old and we have received around 3000 calls.

Over these five years, we have grown from 6 volunteers to a core team of 3 people, 1 follow up counselor, 17 crisis line volunteers, 11 legal line volunteers and a community education team of 10 people (some who are also volunteers for the crisis lines). Every year we train more volunteers to run our lines and this year there will be over 30 people who give their time and expertise without asking for or expecting any monetary gain. Aks has survived all these years because of the dedication and passion of these people who put in their time and heart into making a difference to someone's life.

But as is with every growth story Aks has evolved into an organization beyond anything that I imagined but one that I did hope for. Women look to Aks for professional support, counselling, legal help and advocacy. We are now faced with a tremendous number of calls and the work in gender violence is not only demanding but calls for dedicated resources that can see cases through. A volunteer-only NGO does not benefit Aks in today's scenario and trained personnel and qualified staff have had to move on to other income based models. To answer the current needs of society, Aks not only needs to upgrade to paid employees but expand its core team to keep up with the amount of work. As of now, Even our legal support comes pro bono from Pune and Delhi but going forward we need to have that support inhouse.

Aks today has taken deep roots and needs greater nourishment and all kinds of support to grow into a mighty oak, offering support to all who seek shelter under its bows. I humbly, albeit proudly, acknowledge that though we are a mere speck in the sea of humanity and what we are attempting to do is create ripples in the fabric of the Indian society. Ripples that touch the lives of those in desperate need of some one to hear their wails and stand reassured that they are not alone. Once that is achieved Aks would have done what it set out to do!





## success **STORY**

Date: 22 Apr 2018

Caller: Parth Mishra (Name Changed)

**TIME: 2.32 AM:** PM called and told Neerja, our night time volunteer on duty, that he was speaking from the Police Station in Mumbai. His lady friend and two other girls were harassed and assaulted by a drunk youth and his lady friend's face was badly swollen. He had tried to lodge an FIR at the police station but the Desk Officer refused to lodge an FIR and was merely noting down a simple complaint. The policemen, on his persistence, had sent them to a nearby govt. medical facility for a medical exam of the woman and a blood test of the intoxicated youth, but the facility was closed. The police flatly refused to take them to the govt. hospital some distance away. He wanted our help to have an FIR registered against the perpetrator.

**TIME: 3.05 AM:** Neerja repeatedly tried convincing the Desk Officer to register an FIR even if they could not be taken to the govt. hospital but he was noncommittal. Thereupon Neerja woke up her husband, a retired Brigadier of the Indian Army and asked him to speak to the police officer. Brig Bajaj first sought his name and then politely but firmly requested the Desk Officer to lodge an FIR, give a copy to the complainant and detain the youth. The Desk Officer assured that he would do the needful.

**TIME: 3.25 AM:** Parth rang up again and informed Neerja that the police were using delay tactics and no action was being taken because the youth apparently had political patronage and no amount of convincing by our volunteer seemed to have borne fruit.

**TIME: 3.55 AM:** Once again Brig Bajaj was requested to intervene. This time the Brigadier requested to speak to the police station in-charge. A gentleman named Mr. K came on the line and after a great deal of persuasion (and some veiled threats) the officer was convinced to do his duty to the aggrieved citizens. Mr. K promised to make an FIR, give a copy of the same to Parth and send the intoxicated youth to the govt. hospital at daybreak for a much delayed medical checkup.

**TIME: 4.25 AM:** Parth was spoken to and advised to camp at the police station and not leave till he had a copy of the FIR in hand.

**TIME: 5.55 AM:** Parth was rung up and asked if he had received the copy of the FIR. He confirmed that he had received the same and was leaving the police station!

A routine case for our volunteer to assist an aggrieved citizen but a major boost for Aks and our Cause!
